1.0 AIM

The aim of the Associated and Catholic Colleges of WA (ACC) is to provide quality sport and recreation activities that cater to all levels of student ability. The Inclusive Sports Program (ISP) is integral to the ACC mission and provides students with a disability equitable access to sporting and recreational opportunities. The program is specifically targeted at *students whose disabilities may hinder their inclusion in school based or interschool sporting events*.

1.1 Disability definition

The ACC takes the definition of *disability* from the Western Australia Disability Services Act 1993. The act defines *disability* as meaning a disability:

- which is attributable to an intellectual, psychiatric, cognitive, neurological, sensory, or physical impairment or a combination of those impairments
- which is permanent or likely to be permanent
- which may or may not be of a chronic or episodic nature and which results in substantially reduced capacity of the person for communication, social interaction, learning or mobility, and a need for continuing support services.

Disabilities can result in a person having a substantially reduced capacity for communication, social interaction, learning or mobility and a need for continuing support services in daily life.

2.0 PARTICIPATING SCHOOLS

The Inclusive Sports Sporting program is open to any student with a disability from a member school, whether that school has a designated education support/special needs unit or not. Traditionally the following schools have been involved in the program and the host school would come from within this group each year.

3.0 INVOLVEMENT

It is the policy of the ACC that students competing in ACC sport must be under 19 years of age as of 31st December. Students who have turned 19 years of age are not permitted to participate in ACC sport. It is also ACC policy that student participation is limited to "secondary school students" and that the minimum level for participation is enrolment in Year 7.

The criteria for nomination are as follows:

"Any student with a disability (Years 7 to 12) who has not and are unlikely to represent their school in this sport will be eligible, whether enrolled in an Education Support unit or not. Schools are also encouraged to nominate students whose disabilities prevent them from inclusion in events in school based or house carnivals." ACC inclusion sporting events and programs will not be categorized by or into specific disabilities, but open to all disabilities.

4.0 EVENTS

Activities conducted within the Inclusive sports program are focused on participation rather than competitive performance. Some events are conducted as "stand alone" events whilst others are conducted as parallel events alongside existing divisional carnivals. The current calendar of events offered as part of the ACC Inclusive Sports Program are as below :

5.0 ACC MULTI CLASS PROGRAM

In addition to the ACC Inclusive Sport program of events, the ACC also offer students with a disability the opportunity to compete in a program of ACC Multi Class events. Multi Class events align with ACC major carnivals and inter-school sporting events and are designed to be an integrated competitive sporting program. Multi Class sporting events give students with a disability an opportunity to compete and represent their school.

The three major ACC carnivals of Swimming, Athletics and Cross Country all have an integrated Multi Class component to the event, allowing students with a disability the opportunity to participate alongside members of their school and other competing schools, as well as compete against other students in the Multi Class program.

For students to be eligible for All Stars Team Selection and ACC Records in the ACC carnivals of Swimming, Athletics and Cross Country, students require a disability sport classification relating to that respective sport. Students may compete at these events without a classification (inclusive athlete) however their performance will not be considered for All Stars selection or ACC records. Please contact the ACC office for more information on participating in the Multi Class program and the classification process.

PLEASE NOTE : the ACC divisional carnivals are competitive events, and Sports Coordinators should take careful consideration before nominating an inclusive athlete into an event(s) at an ACC divisional carnival.

6.0 SUB ASSOCATION INTER-SCHOOL SPORT

Several ACC Interschool Sub-Associations also offer integrated sporting competition as part of their weekly inter-school competition. For more information on Sub-Association sport please see: <u>https://www.accsport.asn.au/interschool-sport</u>

7.0 ISP EVENT CHARTERS

As per standard ACC operations, all events and activities conducted within the program will be managed according to the Charter of operations for that activity. Schools will be issued with a charter before each event. Charters can also be accessed on the ACC website under the relevant event page.

8.0 ISP FEES

All ISP events and activities conducted within the Inclusive Sports program will incur a sports fee for each event on a cost recovery basis. These expenses include (but are not limited to) venue hire, first aid, equipment hire, trophies, medallions, catering. These costs will only be invoiced to schools engaging with the respective events. Events are either charged per student / team / school, and for information purposes only, the below provides an indicative schedule of actual 2024 costs, based on nominations received :

8.1 ISP Administration fee

An administration charge of \$155.00 applies to a school who participates in at least one ISP event in a calendar year, which is a flat fee, irrespective of the number of events a school engages in.

9.0 HOST AND DEPUTY HOST SCHOOL

In relation to ISP events, the Host School will, in conjunction with ACC staff, be responsible for the organisation and operation of events as stipulated in the table below. Upon request to the ACC, other schools may wish to volunteer to coordinate ISP events, and if this occurs, then the host school would no longer take on this duty. Effectively, on the carnival day the Host school will be the Carnival Manager. Ideally, the Host School would have assistance from their Physical Education Department and PE Studies/VET students, to run the carnival. ACC staff will provide carnival management and administration assistance with all events.

The main schools involved with the ISP will rotate host duties over regular time intervals. Upon reflection, it was decided that the HOST school will remain (commencing 2024) in the role for a two year term, with the Deputy Host supporting in the second year of term, and taking on role of HOST school the following year.

The below table is the guide to past and future host duty allocations, and will be reviewed annually at the final ISC meeting of each year.

NOTE : The role of the Deputy Host school will be to fulfill the duties of the Host School if the designated school is unable to do so.

10.0 INCLUSIVE SPORT COMMITTEE MEETINGS (ISC)

The coordination and chairing of the ISC meetings will be the responsibility of the ACC Sport Operations Manager, Inclusion. The minutes derived from all meetings are to be circulated within one week of the meeting and is the responsibility of the ACC Sport Operations Manager, Inclusion. New meeting dates will be scheduled as per the ACC calendar. The meetings will take place at least once a term or as a needs basis should more time be required. It is important that all participating schools have a representative at these scheduled meetings.

11.0 GENERAL CONDITIONS OF PARTICIPATION

- **Staffing :** Suitable teaching staff and carers are assigned a group of students in such a way that each school is accompanied by a teacher or a responsible adult acting on written authorisation from the Principal.
- Schools will be responsible to provide officials at the various carnivals/events to assist the ACC & Host School in the overall operation and management. Participation in events is based on the premise that schools will provide the required officials and staff.
- Individual schools should be aware of "Duty of Care" and ensure the presence of sufficient trained staff at the venues.
- Each school engages all necessary staff and meets its own cost in this regard.
- **Dress** : for all sports, players dress standards must be consistent with, and in line with the traditional expectations for that sport. School sports uniform is to be worn at all ACC ISP Carnival events.

12.0 CARNIVAL SHIELDS

The soccer, AFL and cricket carnivals are supported by the respective State Sporting Associations, through the provision of a winner's trophy and perpetual shield. The winning team each year, holds the shield until the same carnival the following year. The school is responsible for engraving the shield at their own cost, prior to the

following years event, and any damage to the shield is the responsibility of the school who is the current holder.

13.0 SUE BIGELOW SPIRIT SHIELD

The Sue Bigelow Spirit Shield is awarded at the ISP Swimming and Athletics carnivals, and the Fun Run & Activity Day. The recipient school is selected by the Host School in consultation with the ACC Sport Operations Manager, Inclusion.

13.1 Background

Sue Bigelow was a dedicated educator who stood as an example of commitment to excellence having demonstrated leadership and achievement within the Inclusive Sport Sector. Sue played a significant part in promoting the participation of students with disabilities and represented a positive image of the sector to the wider community by being one of the driving forces who helped shape the Inclusive Sport portfolio as we know it today. Sue's readiness to improve continually was demonstrated by absorbing and responding to changing skills, needs and attitudes of the Inclusive Sport community.

13.2 Recipient

The receiver of the shield/award will have displayed outstanding commitment and support for the involvement of their students in the respective ACC ISP carnival. The winner of the award will be the school that most embodies the ACC maxim of "Sport in the Right Spirit" and has provided its students with outstanding opportunities for participation, school/team spirit, personal development, and leadership. The following attributes will be used as a guide to assess the merits of each school in the event.

- Participation (competitors, spectators, officials, staff).
- Team spirit/support: cheering, uniform, banners, identity, community.
- Leadership: officials (staff and students), personal responsibility.
- Inspiration/Diversity: participation/involvement above and beyond the norm which serves as inspiration to others.

13.3 Shield rotation

The shield shall be held by the school until the next carnival and rotated from winner to winner. That is, the recipient of the shield for ISP Swimming Carnival shall hand over at the time of the following years ISP swimming carnival, and likewise for the other two events. Each school is responsible for engraving the shield at their own cost prior to the following years event. Any damage to the shield is the responsibility of the school who is the current holder.
